FOIA

Received from Chuck Wehmhoff by email November 16: requests for ordinances about the maintenance of cemetery plots and residential lawns. Regarding residential lawns, Mr. Wehmhoff specifically asked for the ordinance setting grass height before the village has the lawn mowed and setting the costs to the homeowner.

Answered November 16: the Village Clerk sent chapter 93 from the village code of ordinances which rules nuisance issues and ordinance 12-03 which rules cemetery plots. Also, Mr. Wehmhoff was told that paragraphs of chapter 93 of the village code of ordinances footnotes specific ordinances if desired.

I. NEW BUSINESS

Trustee Kavanagh moved, second by Trustee Mau to bring to the table Ordinance 12-42, An Ordinance Authorizing an Intergovernmental Agreement with Ball/Chatham Community Unit School District 5 for Security at the Glenwood Complex. Trustee Herr moved, second by Trustee Mau to bring to the table **Ordinance 12-43**, **An Ordinance Approving an Amendment to an Annexation Agreement (South Park Commons Subdivision)**. Explained by title, 12-43 amends the annexation agreement the village had with the developer of the now defunct South Park Commons Subdivision. The development was zoned for development. Julia Richards Trust and the Dowson Family have requested the property be rezoned.

Attorney John Myers said the legal description attached to 12-43 needs corrected and a plat needs added as an exhibit. Corrections notwithstanding, 2-43 passed by roll call vote 6 yes, 0 no as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - yes, Schatteman - yes.

Trustee Kavanagh moved, second by Trustee Mau to bring to the table Ordinance 12-44, An Ordinance Approving a Contract with Third Millennium Associates, Inc. to Provide Utility Bill Printing and Mailing Services. Explained by title, 12-44 passed by roll call vote 6 yes, 0 no as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - yes, Schatteman - yes.

Trustee Herr moved, second by Trustee Mau to bring to the table **Ordinance 12-45**, **An Ordinance Rezoning Certain Land in Accordance with an Amended Annexation Agreement (South Park Commons Subdivision).** Years ago South Park Commons was zoned for development but that development is now defunct. Following passage of Ordinance 12-43, 12-45 rezones South Park Commons Subdivision property to R1. 12-45 passed by roll call vote 6 yes, 0 no as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - yes, Schatteman - yes.
